

RESOLUTION NO. 2454

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE SPECIAL ELECTION HELD ON NOVEMBER 4, 2008.

WHEREAS, the Town of Payson, Gila County, Arizona, did hold a special election on the 4th day of November, 2008 for the consideration of Proposition 401; and

WHEREAS, Proposition 401 constituted a referendum on the Payson Town Council's July 2, 2008 enactment of Resolution 2395 which approved and adopted a term sheet for the lease of a portion of Town Property in Rumsey Park to the Valley of the Sun YMCA; and

WHEREAS, the election returns have been presented to and have been canvassed by the Mayor and Common Council of the Town of Payson,

NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DO HEREBY RESOLVE AS FOLLOWS:

Section 1. That the total number of ballots cast at said special election was 5688. See Exhibit A attached hereto, Election Summary Report and Official Canvass/Abstract of Vote.

Section 2. That the number of ballots to be verified was 0 and the number of voters found to be ineligible was 44.

Section 3. That the votes cast for Proposition 401 were as follows:

Section 4. That it is hereby found, determined and declared of record that Proposition 401 was not approved and the adoption of Resolution 2395 by the Payson Town Council as herein described was rejected.

Section 5. That Resolution 2395 is hereby declared to be ineffective.
