

RESOLUTION NO. 2543

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DECLARING AS A PUBLIC RECORD THAT CERTAIN DOCUMENT FILED WITH THE TOWN CLERK AND ENTITLED "TOWN OF PAYSON, ARIZONA, EMERGENCY OPERATIONS PLAN", AND ADOPTING THE SAME AS A PUBLIC RECORD.

WHEREAS, A.R.S. § 9-802 provides for the adoption of the provisions of a public record by reference without setting forth the provisions thereof in full in the adopting document; and

WHEREAS, it is the intention of the Town of Payson to adopt the Town of Payson, Arizona, Emergency Operations Plan by reference as a public record,

NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DO HEREBY RESOLVE AS FOLLOWS:

Section 1. That certain document known as "The Town of Payson, Arizona, Emergency Operations Plan" (the "Plan"), three copies of which are on file in the Office of the Town Clerk of the Town of Payson, Arizona, is hereby made a public record by this Resolution Number 2543.

Section 2. The Plan is hereby referred to, adopted, and made a part hereof as if all of its provisions were set forth in full in this Resolution No. 2543.

Section 3. Three copies of this Resolution Number 2543 and of the Plan shall be maintained on file in the Office of the Town Clerk and kept available for public use and inspection, except such parts thereof as are confidential for homeland security and local security purposes or that are otherwise made privileged or confidential pursuant to A.R.S. §§ 38-431.03, 39-101, or pursuant to any state or federal statute or court order.

Section 4. If any section, subsection, sentence, clause, phrase or portion of this Resolution Number 2543 or of the Plan is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of either this Resolution or said Plan.

Section 5. That the Town of Payson be and is hereby authorized to take and perform such other and further actions as are necessary or appropriate to carrying out the intent and purposes provided for in this Resolution Number 2543.
