

**RESOLUTION NO. 2564**

**A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE A DESIGNATION OF APPLICANT'S AGENT FORM FOR THE ARIZONA DIVISION OF EMERGENCY MANAGEMENT.**

**WHEREAS**, following a severe winter storm in January 2010, the Town of Payson applied for public assistance funding from the Arizona Division of Emergency Management; and

Galbraith, Town Manager of the Town of Payson, be and is hereby appointed as the Town's agent in matters relating to its application for public assistance funding from the Arizona Division of Emergency Management, including authorization to sign agreements with the Arizona Division of Emergency Management on behalf of the Town of Payson.

Section 2. That the Arizona Division of Emergency Management Designation of Applicant's Agent Form, attached hereto as Exhibit "A" and made a part hereof, be and is approved in substantially the form as attached.

Section 3. That Kenny J. Evans, Mayor of the Town of Payson, be and is hereby authorized to execute said Designation of Applicant's Agent Form in substantially the form as attached.

Section 4. That the Town of Payson be and is hereby authorized to take such other and further actions as may be necessary or appropriate to carrying out the intent of this Resolution Number 2564.
