

RESOLUTION NO. 2571

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE A GRANT APPLICATION TO THE ARIZONA DEPARTMENT OF TRANSPORTATION FOR TRANSPORTATION ENHANCEMENT GRANT FUNDING FOR PEDESTRIAN IMPROVEMENTS IN GREEN VALLEY PARK, AND PROVIDING FOR 5.7 PERCENT MATCHING FUNDS.

WHEREAS, the Arizona Department of Transportation (ADOT) is soliciting applications for its Arizona Transportation Enhancement Grant; and

WHEREAS, the Town of Payson desires to apply for funds from this Program for pedestrian improvements in Green Valley Park,

NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DO HEREBY RESOLVE AS FOLLOWS:

Section 1. That the Town of Payson be and is hereby authorized to make application to the Arizona Department of Transportation Enhancement Program for funding for pedestrian improvements in Green Valley Park, including lighting in the Park.

Section 2. That Kenny J. Evans, Mayor of the Town of Payson, be and is hereby authorized to execute said application for Arizona Transportation Enhancement Program funds and any other agreements required by the Arizona Department of Transportation for such purposes.

Section 3. That the Town of Payson shall comply with all appropriate procedures, guidelines, and requirements established by the Arizona Department of Transportation as a part of the process for applying for Arizona Transportation Enhancement Program funds.

Section 4. That the Town of Payson commits to fund (1) the 5.7% match for any grant funds, to include any project scoping documents and environmental assessments that may be required, as well as all right-of-way and utilities clearances and designs that may be required (2) the entire ADOT review fee, and (3) 100% of all cost overruns.

Section 5. That the Town of Payson commits that the project will be ready for advertisement for bids within three years.

Section 6. That if the project is canceled, the Town will reimburse ADOT for all federal funds used on the project.

Section 7. That the Town of Payson is committed to the Joint Project Administration (JPA) maintenance agreement in perpetuity.
