

RESOLUTION NO. 2657

A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, APPOINTING JACK BARKER AS THE TOWN'S PERSONNEL HEARING OFFICER AND ELLEN VAN RIPER AS THE TOWN'S ALTERNATE PERSONNEL HEARING OFFICER.

WHEREAS, on February 16, 2012, the Town Council approved Resolution 2650, adopting an amended Personnel Policy Manual; and

WHEREAS, Section 4 of Resolution 2650 directed the Town Attorney to present candidates for possible appointment as the Town's Personnel Hearing Officer pursuant to Section 4.5 of the amended Personnel Manual; and

WHEREAS, the Town solicited and has received resumes and information regarding fees from attorneys Jack Barker and Ellen VanRiper; and

WHEREAS, both of these attorneys have training and experience in personnel matters and are willing to act as the Town's Personnel Hearing Officer,

NOW, THEREFORE, THE MAYOR AND COMMON COUNCIL OF THE TOWN OF PAYSON, ARIZONA, DO HEREBY RESOLVE AS FOLLOWS:

- Section 1. Jack Barker is hereby appointed as the Town's Personnel Hearing Officer pursuant to Section 4.5 of the Town's Personnel Manual, as of April 1, 2012.
- Section 2. Ellen Van Riper is hereby appointed as the Town's alternate Personnel Hearing Officer pursuant to Section 4.5 of the Town's Personnel Manual, as of April 1, 2012.
- Section 3. If for any reason, Jack Barker and Ellen Van Riper are unavailable, have a conflict of interest, or are precluded by state law from hearing an employee appeal (other than an appeal filed by the Town Attorney), the Town Attorney is hereby authorized to select an additional alternate Personnel Hearing Officer. If the appeal in such case has been filed by the Town Attorney, the Town Manager is hereby authorized to select an additional alternate Personnel Hearing Officer.
