

RESOLUTION NO. 2810

A RESOLUTION OF THE MAYOR AND PAYSON TOWN COUNCIL,
DECLARING AND ADOPTING THE NOVEMBER 4, 2014 PRIMARY
ELECTION RESULTS AND DECLARING AN EMERGENCY.
