

RESOLUTION NO. 2956

A RESOLUTION OF THE TOWN OF PAYSON, MAYOR AND TOWN COUNCIL AND PURSUANT TO A.R.S. § 9-821 TO CANVASS THE RETURNS, DECLARE THE RESULT OF THE AUGUST 30, 2016 PRIMARY ELECTION, ISSUE CERTIFICATES OF ELECTION AND DECLARE AN EMERGENCY.

WHEREAS, the Town of Payson, Gila County, Arizona, held a Primary Election on the 30th day of August, 2016 for the election of a Mayor and three Council Members; and

WHEREAS, pursuant to A.R.S. § 9-821, the Town of Payson shall canvass the returns, declare the result and issue the certificates of the election; and

WHEREAS, pursuant to A.R.S. § 9-821.01, the Town of Payson shall declare elected candidates for Mayor and City Council pursuant to the statutory calculation formula provided under A.R.S. § 9-821.01 (D) (1-3); and

WHEREAS, the election returns have been presented to and have been canvassed by the Mayor and Town Council,

NOW, THEREFORE, THE MAYOR AND TOWN COUNCIL RESOLVE AS FOLLOWS:
