RESOLUTION NO. 3250

A RESOLUTION OF THE MAYOR AND PAYSON TOWN COUNCIL ADOPTING WATER RATE INCREASES.

WHEREAS, pursuant to A.R.S. § 9-511.01(A)(2), at its regular meeting on April 8, 2021, the Mayor and Town Council adopted a Notice of Intention to increase water rates and established June 10, 2021, as the date for public hearing on the proposal to increase rates; and

WHEREAS, at least sixty days have passed since the adoption of said Notice of Intention and scheduling the public hearing; and

WHEREAS, a copy of the Notice of Intention showing the date, time, and place of such public hearing was published in accordance with A.R.S. § 9-511.01(A)(2) in the April 16, 2021 edition of the *Payson Roundup*; and

WHEREAS, a written report and data supporting the increased long term water rates has been made available to the public by the filing of a copy in the Office of the Town Clerk at least thirty days prior to the public hearing held on June 10, 2021. A copy of the report and data was also placed on the Town's website; and

WHEREAS, the Mayor and Town Council have held a public hearing on the proposed water rate increase and have otherwise complied with the requirements of A.R.S. § 9-511.01 and other relevant provisions of law; and

WHEREAS, the Mayor and Town Council have determined that the rates set forth in this Resolution are just and reasonable.

NOW, THEREFORE, THE MAYOR AND TOWN COUNCIL RESOLVE AS FOLLOWS:

- Section 1. That the water rates and effective dates set forth as in Exhibit A attached are adopted.
- Section 2. All other resolutions and parts of other resolutions in conflict with provisions in this Resolution are hereby repealed to the extent of such conflict.
